- a major source of individual information concerning family matters (union formation and dissolution, fertility, etc.)





- Counting the individual bulletins and using sex, 'being in a couple' status and date of birth
- A family is the part of a household with at least two persons who are :
 - a **couple** and their **children** (if any in the household) ;
 - an **adult with his/her child** (single-parent family).
- In a family, a "child" is necessarily single and childless.
- A household can include **zero, one or two** families.




- Family survey allows a better perception of couple situations
- The use of the question "do you live couple" in the EAR is not sufficient for the construction of cohabitation modality (MoCo).

Same-sex couples in the census


89% of same sex cohabiting partners declare living in a union.

How are coded the persons belonging to HH where lives a same sex couple?







Conclusion (1)

Census data enumerates HOUSEHOLD members

- The family types available are 'limited' by the criteria of coresidence
- French census reconstructs the family ties within the HH
 - not only emerging types of families are misclassified:
 - lone parent families tend to be over-estimated
 - isolated adults may be engaged in stable relationships
 - More complex types are ignored

Conclusion (2)

Family survey data describe FAMILY membersThey can be difficult to match with census data

A wide discussion is taking place on the concepts of Household and Family

The vision of the nuclear family is challenged by Family survey data which exhibit the diversity of relationships taking place between household

The necessity to assess the capacity of the data to the describe the reality of the situations.
